

**Spokane Teachers Credit Union (STCU) Fill
‘er Up Promotion Rules**

No purchase is necessary to enter or win.

**Membership in STCU Fill ‘er Up and deposit into
STCU First5 Savings Account during promotion period is required to enter.
Must be 17 or younger to win.**

All entries received prior to April 30, 2025, will be included in Group 2 for drawings.

All eligible existing Fill 'er Up members and new eligible Fill 'er Up members that submit the "Fill 'er Up Enrollment Form" by dropping it by an STCU branch or mailing it to STCU by the end of any Promotion Period will be automatically entered in that period's promotion and the remainder of any Promotion Periods, unless requested otherwise. In addition to enrollment in Fill 'er Up, a single deposit of at least \$1 must be made into an STCU First5 Savings Account within the past 90 days from the end of the applicable Promotion Period. Interest deposits are not eligible deposits. The "Fill 'er Up Enrollment Form" will be provided during the Promotion Periods on www.stcu.org/youth. The form will also be available in STCU branch locations.

Eligibility: No purchase necessary to enter. Participants and winner(s) must be U.S. residents, be 17 or younger, and be a member of STCU Fill 'er Up as described herein. Must be a Fill 'er Up member and deposited at least \$1 into a STCU First5 Savings Account prior to the end of each Promotion Period to be eligible to win during each Promotion Period. Fill 'er Up members who joined prior to the commencement of the Promotion Periods are eligible to participate and win if the deposit requirements are met as described herein. Winners will not carry forward to other Promotion Periods. Participants 17 and under must have a parent or guardian as a joint owner on the account and such parent or guardian must consent to enter this Promotion. Employees of STCU, its subsidiaries, advertising agency and the immediate family of any such persons (spouse, parents, siblings and children and each of their spouses) and persons living in the households of each of these individuals whether related or not are ineligible to enter and win. Only one (1) entry per person per Promotion Period. STCU Fill 'er Up members may only win one prize during Promotion Periods, both current and future. Only one person per household may be a Fill 'er Up winner in any two-year period.

Drawing: Within five (5) business days following the last day of each Promotion Period, a random drawing will be conducted of all eligible entries received during the just ended Promotion Period. There will be one (1) drawing for each of the twelve (12) Promotion Periods throughout the year. One (1) winner per period will be selected through a random and standard drawing to be conducted by STCU in its sole and absolute discretion. Winners will be notified by telephone and need not be present to win.

Odds: Odds of winning are determined by the number of entries received. Many may enter but only one will win per Promotion Period.

Prizes: The winner of each Promotion Period is to have their STCU First5 Savings Account "filled up" to get to a balance of \$500. The First5 Savings Account balance at the end of the applicable Promotion Period will be used when determining the actual prize amount. Total value of each prize will not exceed \$500. Total value of all twelve (12) prizes will not exceed \$6,000.00.

Prize Restrictions: Prizes are not transferable. Each winner is solely responsible for reporting and paying applicable state and federal taxes. The value of any prize awarded to a winner may be reported for tax purposes as required by law. Each winner must provide STCU with valid identification and a valid taxpayer identification number or social security number before any prize will be awarded.

Prize Claims: Each winner will be notified by telephone. If a winner is disqualified, STCU reserves the right to conduct another drawing to determine an alternative winner or not to award that winner's prize, in its sole discretion. If a prize is unclaimed within 90 days from the date of the drawing, the prize may be forfeited and awarded to an alternate winner.

Winner List: For the names of the winners, mail a self-addressed, stamped envelope to STCU, Community Engagement and Impact Dept., 1620 N. Signal Dr, Liberty Lake, WA 99019. Requests must be received by December 31 of the year following the year of the contest.

Publicity: By participating, all participants and winners grant STCU the exclusive permission to use their names, characters, photographs, voices, and likenesses in connection with the promotion of this and other drawings and/or sweepstakes and waive any claims to royalty, right or remuneration for such use. This includes the website and social media channels.

Under no circumstances will any participant be permitted to obtain awards for, and each participant hereby waives all rights to claim, punitive, incidental, or consequential damages, or any other damages, including attorneys' fees, other than actual out-of-pocket expenses (i.e., costs associated with entering the Promotion), and waives all rights to have damages multiplied or increased under any federal or state law.

Miscellaneous: This Promotion is void where prohibited. STCU may substitute prizes of equivalent value, amend the rules or discontinue the Promotion at any time. STCU disclaims any responsibility to notify participants of any aspect related to the conduct of this Promotion. Written copies of these
