Public policy and advocacy.



STCU advocates on behalf of our members and communities. We're a longtime supporter of school bonds and levies, and a regional leader in tackling the workforce housing shortage.

In 2024, STCU secured nearly \$200,000 for critically needed workforce housing projects. The grants included:

Our \$25,000 donation to Habitat for Humanity–Spokane's Women Build Program was triple-matched by the Federal Home Loan Bank of Des Moines.

\$43,544

STCU's donation to the Panhandle Affordable Housing Alliance was supported with additional funding from the Federal Home Loan Bank of Des Moines through the GoWest Foundation. The alliance works to provide housing for moderate-income workers in Kootenai County, where the median price of single-family homes has more than doubled in recent years.

\$30,000

STCU's contribution to LEAP Housing was amplified with additional funding from the Federal Home Loan Bank of Des Moines through the GoWest Foundation. It supports a six-unit workforce housing project in Priest River. LEAP is a non-profit that works to provide access to safe, stable, and affordable homes for Idahoans.

\$25,000

Our contribution to Spokane's Northeast Public Development Authority supports the Wellesley Project, a workforce housing and affordable childcare facility.



In 2024, STCU was awarded the Hope Builder Award from Habitat for Humanity-Spokane, for supporting efforts to provide affordable workforce housing.
